Since tuition only covers a partial amount of the total cost of educating your child(ren) at St. Patrick School, we require your assistance in our fundraisers to help make up the difference. Please elect from the following options to meet your **\$400 Family Fundraising and Scrip Requirement**:

I. Fundraising Requirement: **\$350 Profit**

Options (please check one):

- I/We choose to participate in St. Patrick School Fundraisers. We understand that 50% (\$175) must be met by December 31, 2019 or we will be billed for any unearned profit, due in TADs by Jan 25, 2020. The requirement must be met in full by April 30, 2020; any remainder will be billed and due on TADs by May 25th. For families with an 8th grader, fundraising must be completed by April 30, 2020. Profits in excess of \$350 may be credited to volunteer service hours at a rate of \$12/hour.
- Fundraising Buy Out:** I do not wish to participate in fundraisers. I understand that the Fundraising buy-out fee will be \$350. Billing and payment will be done in TADS.
 - I/We choose to pay the **full amount** of \$350 by Sept. 25, 2019
 - I/We choose to make **two** \$175 payments (first due by Sept. 25, 2019 and other due Jan 5, 2020)
 - I/We choose to pay on a monthly basis (10 installments of \$35 each from **Aug-May**). **For families with an 8th grader**, it will be **9 installments** of \$38.89 each from Aug-Apr.

II. SCRIP Requirement: **\$50 Profit**

Options (please check one):

- I/We choose to participate in St. Patrick School **Scrip Program**. We understand that 50% (\$25) must be met by December 31, 2019 or we will be billed for any unearned profit, due in TADs by Jan 25, 2020. The requirement must be met in full by April 30, 2020; any remainder will be billed and due on TADs by May 25th. Profits in excess of \$50 will be carried over to the Fundraising Requirement.
- Scrip Buy Out:** I do not wish to participate in Scrip. I understand that the Scrip buy-out fee will be **two** \$25 payments (first due by Sept. 25, 2019 and other due Jan 5, 2020). Billing and payment will be done in TADS.

I/WE HAVE READ AND ASSUME FULL RESPONSIBILITY FOR THE FUNDRAISING PARTICIPATION/PAYMENT COMMITMENT FOR OUR CHILDREN DURING THE PERIOD OF ENROLLMENT AT ST. PATRICK SCHOOL UNDER THE TERMS WHICH I/WE HAVE INDICATE ABOVE.
